CAM Conference Video

We videotaped all speakers at CAM's 2010 annual conference in November. It has been a learning experience. *The recordings are not broadcast quality.* The recordings for one or two speakers are only marginally useful.

Requirements Federal Motor Carrier Safety Administration

AMSA advises that new hours-of-service regulations are being considered in the USA. The FMCSA has issued its proposed revisions to their Hours-of-Service requirements for commercial truck drivers. Past experience has been that Canadian regulations follow the US model and these will be the regulations that movers working in cross-border service will have to follow. A copy of the new proposed rules has been <u>posted</u> (pdf).

The proposed rule would make seven changes from current requirements. First, the proposed rule would limit drivers to either 10 or 11 hours of driving time following a period of at least 10 consecutive hours off duty; on the basis of all relevant considerations, FMCSA currently favors a 10-hour limit, but its ultimate decision will include a careful consideration of comments and any additional data received. Second, it would limit the standard "driving window" to 14 hours, while allowing that number to be extended to 16 hours twice a week. Third, actual duty time within the driving window would be limited to 13 hours. Fourth, drivers would be permitted to drive only if 7 hours or less have passed since their last off-duty or sleeper-berth period of at least 30 minutes. Fifth, the 34-hour restart would be retained, subject to certain limits: The restart would have to include two periods between midnight and 6 a.m. and could be started no sooner than 168 hours (7 days) after the beginning of the previously designated restart. Sixth, the definition of "on duty" would be revised to allow some time spent in or on the CMV to be logged as off duty. Seventh, the oilfield operations exception would be revised to clarify the language on waiting time and to

state that waiting time would not be included in the calculation of the driving window.

Cell Phones on Canada's Do Not Call List

There is a persistent e-mail circulating through Canada and the USA stating that all cell-phone numbers will be released to telemarketers and that all cell phones should be registered on the National Do Not Call List (DNCL). Cell-phone numbers will not be released to telemarketers.

Wireless telephone providers would require the permission of each of their subscribers before they could create or release a directory of cell-phones. Consequently, a national cell-phone directory is not available. But it can't hurt to register your cell-phone number with the DNCL.

Two of Canada's leading moving families have joined forces as one as a result of succession planning at the Hoyt Group of Companies. Hoyt's has been sold to a new group of partners including Campbell Bros. Movers, Randy Hoyt and Barry Hoyt.

There will be a tremendous opportunity ahead for all of the staff at Hoyt's and Campbell's through the synergies created between the two companies by the new ownership.

Together these companies book over \$12 million in total registered linehaul revenue per year with United Van Lines. The staff and management are very excited about the future potential of their two moving companies working as one with coverage in Ontario and Atlantic Canada.

Conditions of Carriage

The content of the Conditions of Carriage on the back of your bill of lading is one of the most difficult items to explain in full to a prospective customer and to justify to a customer with a complaint. Disclosure is the first principle in the sales manual for sales people.

We have just had a couple of complaints come through the office in which a proper explanation of the conditions of carriage would have helped the situation. In one case, the consumer was claiming for damage to an item that had been previously damaged and to a piece of furniture made from compressed paper (even weaker than particle board). Had the mover told the consumer that he would accept no responsibility for either item in transit, most of the problem would have disappeared.

You should be aware that the term "inherent vice" has been taken out of some provinces' conditions of carriage. (Inherent vice is the term used in Conditions-of-Carriage regulations to describe goods that by their construction are subject to damage in transit – particle-board furniture, electronics, appliances, etc.) This makes you responsible for damage of this sort unless you have the consumer sign a waiver or protect the goods in some fashion. And,

of course, in the interest of customer relations, it's better to tell the customer in advance rather than surprising him or her after the fact. A sample waiver form is available on CAM's website.

In the other case, the damage claim exceeded the mover's deductible. Had the mover explained to the customer that the claim would be handled by its insurer, a lot of back and forth communications would have been saved.

Scam

CAM has just been informed of a scam relating to credit-card charges for a move with an overpayment and a cash payment in return. The credit card owner then denies the charge to the credit card company. The mover has difficulty in proving the difference between the estimated value, the price on the bill and the amount charged. We thought you might want to hear about this.

Canadian Professional Movers Course

In 2010, 39 moving professional graduated from CAM's <u>Canadian Professional Movers</u> course. Congratulations to them all.

Another Scam

A company claiming to operate in a West African country has been implicated in a scam. In this scam, a "client" emails a legitimate moving company requesting that the mover contact an "agent" with logistical information and costs for delivering goods from West Africa to the USA.

The "client's" email is quickly followed by one from the "agent", with an invoice attached. The "agent" states that an air waybill will be sent, along with clearance papers for delivery of the items, but that a bank wire of an amount exceeding \$2,000 US for "demurrage and storage fees" must be received before the "agent" can forward details of delivery and pickup.

IAM shared this information in an effort to alert members to current scams, and to the tactics of such scam artists, which, as one IAM member observed, "can sound convincing to untrained ears." Thanks to Tony Cleary for the warning.

These scams seem to be popping up on a regular basis. For ones that appear to originate in Canada, you can report them to the Canadian Anti-Fraud Centre at 1-888-495-8501 or visit the Centre at www.antifraudcentre.ca. Two general reminders about scams:

If you haven't got the paperwork and don't know the mover, don't issue the money!

and

Never give a cash advance on a credit card unless you are a bank!

Postal Strike

Fraudulent Reviews

We have had a warning from a member about fraudulent reviews being posted to consumer websites. You should be aware that some of your less-than-reputable competition may be posting reviews of your company. A sign of this is a grouping of poor ratings for your company and stellar ratings for others. We recommend that you do a search for your company by name and/or by city. Fake reviews should be reported to the website management.

Conditions of Carriage

Have you ever asked where the *Conditions of Carriage for Household Goods* on the back of your bill of lading come from? The source is your province's highway traffic act, traffic safety act or other similar legislation. Eight of ten provinces have enacted these conditions in legislation as well as specifying the minimum content for the information on the front of the bill of lading.

The term "Conditions of Carriage" is often preceded in the regulations as "Specified" or "Uniform". This means that the wording cannot be modified. It's probably time that you compared your bill of lading to your province's regulations. CAM has just dealt with a consumer complaint in which the mover (a CAM member!) had modified the document with a number of clauses that were not in the regulations and directly contradicted the intent of the legislation, which is to protect the consumer who is an unsophisticated shipper.

You can see the <u>Conditions of Carriage</u> for your province on our website but you should check with your provincial government's website for the absolutely latest version.

Toronto Police Service Activities

Around this time last year we reported that the Toronto Police Service had arrested a local Toronto mover and charged the employees with many crimes including fraud, extortion, theft and possession of stolen goods. Sergeant Kevin Hooper discussed this at our 2010 Annual Conference.

The Province of Ontario's Asset Forfeiture Unit has seized all of the company's moving trucks, two personal cars and one residence thus far. It will be a year before this goes to trial. The Province cannot sell the property until a judge agrees at trial that the property was obtained by crime (i.e., by defrauding the victims of thousands of dollars which allowed the bad-guys to buy trucks, house, etc.).

A New Scam

In the last week, we have been approached by two different companies offering to sell us tickets for attendance at the Masters and the US Open golf tournaments. They advised that a client of theirs is unable to attend and they are offering us the tickets. The tickets are several thousand dollars and must be paid for immediately. Draw your own conclusions. It may not be a scam but it sure sounds like one. CAVEAT EMPTOR!

City of Toronto Licensing

The Toronto Police Service has presented a request to the City of Toronto's Licensing and Standards Committee that a permit be required for movers operating within the city. The Police Service was represented by Sgt. Kevin Hooper and CAM was represented by Perry Thorne of Greg & Sons Moving and Storage and Chuck Resnick of Two Men and a Truck.

Committee members were very enthusiastic about the request that Sgt. Hooper presented. They voted unanimously to present the request to the Government of Ontario for approval. There are a number of issues that will have to be addressed in the process of developing the permit process:

- What standards will be required for movers to obtain a permit?
- What will be required from movers who are not resident in the city of Toronto?
- Who will enforce the permit regulations?
- What mechanisms will be in place to assist consumers?
- Should this be an Ontario-initiative?

These are issues that CAM will need to address in the near future and will need your input. As is often the case, this initiative could find itself on the agendas of other city councils across Canada.

Join us at the Annual General Meeting during the Annual Conference where we will discuss this matter and set CAM's policy on permits for movers.

Bedbugs



CAM Annual Conference — A Social-Media World — The New Business Reality

On November 13–15, the Canadian Association of Movers held its 16th Annual Conference in Toronto. The conference included three major events in CAM's year:

- The Annual Conference
- The Suppliers' Trade Show
- The Annual General Meeting
- The Annual Awards Dinner

Each of the events had its own value and importance for members and attendees. The Annual Conference is intended as a business conference for movers. Its emphasis is on business concepts and practices that movers would find useful. This year the conference was titled *A Social Media World – The New Business Reality*. To deliver messages in support of that theme, CAM engaged speakers across a broad range of topics:

- A highly rated consumer advocate who discussed the perils of not hiring a good mover
- A consultant who provided an outline of effectively using social media for business purposes
- An economist who discussed the future of the North American and global economies
- A police officer from Canada's anti-fraud center who showed attendees some of the scams that they could be vulnerable to and offered contact information for reporting fraudulent behaviour
- Terry Head, president of the International Association of Movers (IAM), spoke on the future of international moving and the profit opportunities that this sector opened for movers.

<u>Conference presentations</u> have been posted.

A dozen of CAM's suppliers displayed their wares and services at the conference. Members were able to see the latest in moving services, equipment and supplies, vehicle transportation, and insurance products.

CAM's Annual Awards

Three presentations were made at the Annual Awards Dinner during the conference:

- The Distinguished Service Award was presented to Howard Bigham of Bigham the Mover for his role in the re-establishment of CAM 15 years ago, the ongoing management of CAM and the example he sets in providing ethical professional moving services.
- The Industry Achievement Award was presented to Dennis Doehl of Jay's Moving & Storage (accepted by his son, Greg) for his entrepreneurship in the establishment, management and expansion of Jay's.

• The Public Service Award was presented to Dale Goldhawk, Canadian consumer advocate and broadcaster, for his ongoing efforts in helping consumers find reputable service-providers (especially movers).
